

SITE APPLICATION FORM 110th Annual Kojonup Show

CONDITIONS UNDER WHICH GROUND SITES WILL BE HIRED

1. The rules of the Kojonup Show P & A Society shall be the Uniform By-Laws as may be adopted by the Society from time to time.
2. The Committee shall not be held liable for any damages or loss suffered by the Applicant through actions or events of any kind by persons, or Acts of God, or variance trade.
3. Every reasonable care has been taken of the Grounds and Buildings. The Society will not be held responsible for any accident that may be caused through or by an Applicant, and it shall be a condition of Applicant that each Applicant shall hold the Society blameless and indemnified against any legal proceedings arising from such accident.
4. The Society will not be responsible for any insurance costs covering the property of the Applicant.
5. The Committee reserves the right to refuse entry to, or have removed from the grounds any person or article.
6. The Applicant shall be responsible for any damage incurred while the ground sites are in their use. The Society shall have the right to collect costs for any repairs.
7. The grounds shall be left in a clean and tidy condition after use by the Applicant.
8. No free gate tickets are issued, other than those indicated for paid sites, as over.
9. No cap activated appliances (eg guns, rifles, pistols, rockets, etc) are allowed on the Kojonup Show Grounds.
10. Payment must be made **at least two weeks before the show** if you wish to receive the gate tickets allowed in site fee. Otherwise all individuals working on the site will have to pay gate entry fees on arrival at the Show Grounds. These will not be reimbursed.

All gate passes will be sent to the applicant prior to the Kojonup Show, provided that payment is received at least ten working days before the show date. Additional gate passes can be purchased at a cost of \$10 each; this can be added on to the site fee.

ELECTRICITY

Electricity will not normally be made available to ground sites. Under extra-ordinary circumstances the Committee will provide power at a minimum charge of \$15.00 plus usage. Special application for power should be made to the Secretary, in writing, at least ten days prior to the Show.

PERSONS STAYING AFTER SHOW DAY

The P & A Society requests that persons staying at the Showgrounds after the Show pay \$11.00 per day camping fee to cover the costs of power, water and other Showground Facility charges.

Extract from Schedule: RULES AND BY-LAWS

The rules of the Kojonup P & A Society (Inc.) with regards to the Annual Show shall be the uniform by-laws of the Royal Agricultural Society and such other by-laws as may be adopted by the Society from time to time.

Responsibility for Accidents

Every reasonable care will be taken of exhibits, but the Kojonup P&A Society (Inc.), or any of its officers will incur no responsibility. Ordinary precautions will be taken to protect the property of the Society and exhibits, but exhibits will not be insured at the cost of the Kojonup P&A Society (Inc.) The Kojonup P&A Society (Inc.) will not be held responsible for any accident that may be caused through or by any exhibitor or exhibit, and it shall be a condition of entry that each exhibitor shall hold the Kojonup P&A Society (Inc.) blameless and indemnify against any legal proceedings arising from such accident.

Tents, Booths, etc:

All tents and booths, other than Sideshows, shall, before noon on the day of the show, pay such fees as may be fixed by the Committee, and should this fee be not paid, such tent, booth or sideshow shall be under penalty of removal from the ground. The Kojonup P&A Society (Inc.) shall not be held liable for any loss of income or damage suffered by the lessees through actions or events of any kind of persons, Act of God or vagaries of trade.

Committee's Right: The Committee reserves the right to refuse entry to, or have removed from the ground, any sideshow, person or article; refuse to accept an entry for any exhibitions in any section without explanation.
